What about Rape? How Do You Answer?



Education: Monica Kelsey, although very happy with her adoptive family, was eager to see her birth records when she turned 18. She was shocked to find that her birth mother had been brutally raped. In 1972 her life was protected by law, but at the advice of her own mother, her birth mother did go to a back-alley abortion clinic before changing her mind to have her baby. Today Monica is a firefighter and medic who has saved more lives than she can count. As her birth mother was dying, Monica was able to be there with her and hold her hand. She is married and has three children and thanks her mother as well as God for giving her the gift of life. (1)

Many people hold onto the justification of abortion in the "hard cases" of rape and incest, feeling compassion for the women who been victimized. And when faced with this question, we want to immediately establish the common ground of empathy for the rape victim — "Rape is a terrible thing to happen to any woman." However, the consensus opinion of women who became pregnant after sexual assault was that they <u>did not want abortions</u> — that baby is her child, too, not just the rapist's child. If women did abort in response to pressure, they reported that the abortion only increased their experience of grief and trauma. (2) Those who chose life did not regret their decision. "Many of these women said that their children had bought peace and healing to their lives."(3) God can indeed bring good out of evil.

However a child is conceived, he or she is still a precious new life, and does not deserve to be killed because of the crime of the father. In the case of incest, an abortion in addition serves to hide the sexual abuse rather than give the exposure that may lead to ending the abuse.
