



Children Acquired in Bulk - Commercial Surrogacy



Education: The family is the primary unit of society, where children are created by God through the expression of love between their parents. In Vitro Fertilization (IVF) separates procreation from marriage, making it possible to choose which few of many created would be transferred to mature in a woman's uterus. Surrogate mothers are sometimes used to nurture the child during the pregnancy and then release the child to the "parents", who may or may not have

any biological relationship to the child. In commercial surrogacy, women in need are paid to carry the artificially conceived children. A recent article describes this practice, and its implications for society. (1)

Xu Bo is a Chinese billionaire who has been said to have fathered over 100 children using surrogate mothers, some of whom were delivered their child in the United States, making their children U.S. citizens. His intent is to produce a large number of boys, from whom he will choose the best to take over his business.(2) There was no indication of any intent to develop relationships with these children. Shortly after that story ran, another exposed how surrogate mothers were recruited from Thailand and brought to Georgia (in eastern Europe) and trapped by being required to pay exorbitant costs, which they could raise only by selling their eggs.(3) They were given fertility medication and received sperm from multiple men in order to get pregnant. Or an implantation would be done with one or more embryos created by IVF. They were paid when a heartbeat was detected and again later after birth. They were given food and housing – in poor conditions - while they were pregnant. They did not see their babies after delivery, and never met the "parents" who would raise them, or knew their ultimate fate.

The global fertility industry avoids regulations by separating the varied components needed. Eggs and semen can be imported, embryos can be created in Georgia, and Thai women can be used as surrogate mothers who release the children to a Chinese parent to go "home" to China. Two African surrogates described how they would be "sold" from recruiter to agency to clinic. They accepted their fate as being better than what they might expect in other circumstances.
